## Child Care Transportation Training Participant Information

### Regulation Requirements

The Nebraska Department of Health and Human Services, Children's Services Licensing Under Child Care Centers, Regulation 3-006.10C, added a requirement that child care center staff members who transport children are required to attend the three-hour Child Care Transportation Training. This regulation was implemented May 20, 2013. All newly hired staff who will be transporting children have 90 days to complete the training after their date of hire. The training is valid for five years. The purpose of this requirement is to ensure that child care staff are able to properly install and use child passenger safety seats in the child care center's vehicle.

### Training Information

Safe Kids Lincoln-Lancaster County will provide the training to Lancaster County child care center staff. Registration is required to attend this training. Maximum number of participants per training is 20; minimum is 5. Trainings with less than 5 registrations will be subject to cancellation. The fee is \$30.00 per person, and this registration and fee must be received at least 48 hours in advance of the training.

The child care center is required to bring the center's vehicle used for transporting children. Arrive 10 minutes prior to start time to sign-in. A certificate of attendance will be issued at the end of the training.
